Professional Roles & Practice Standards Committee: PC Task Force

Our Goals for 2021 and 2022 include:

- 1. To educate our membership, as well as our larger community to what a PC is and can do, including discussion of the practice guidelines, and the necessary training and expertise needed to serve in the role;
- 2. To create a sense of protocol/best practices around the use of PC's and have it be research referenced, based on AFCC Guidelines and less of a free-for-all;
- 3. Create a template for a methodology/judicial training- so judges know what to expect from a PC;
- 4. Facilitate a Round Table- a state-wide stake-holders conversation about what should be included in a good PC Order;
- 5. To integrate the newly revised AFCC Parenting Coordination 2019 Guidelines into our PC work in all 39 WA. State Counties, and into our PC work that appears before the Washington Courts.
